NOTICES OF MOTIONS

I. Minister of Industrialization, Trade and SME Development:

That leave be given to introduce a Bill to establish the Business and Intellectual Property Authority; to provide for its powers and functions; to provide for the Board of BIPA and its powers and functions; to consolidate certain offices; to amend certain laws; and to provide for incidental matters.

II. Minister of Industrialization, Trade and SME Development:

That leave be given to introduce a Bill to amend the Liquor Act, 1998, so as to provide for the issuing of licences to establishments within a prescribed distance in the vicinity of certain areas and the inclusion of residential premises and hospitals as an additional factor to be taken into account when considering a licence application; to provide for the inclusion of a representative of the Ministry of Industrialization, Trade and Small and Medium Enterprises Development, local authorities and traditional authorities in Regional Liquor Licensing Committees; to provide for the regulation of the selling of alcohol in retail outlets linked to petrol and diesel service stations outside the prescribed hours; to empower the Minister to prohibit the sale of alcohol at certain public premises; to provide for the imposition of administrative penalties for contravention of the Act; to increase the penalties for certain offences; and to provide for incidental matters.

III. Mr. Nekundi:

That this Assembly –

- (i) *Discusses* the prevailing situation of foreigners occupying entry positions and other positions of which Namibians have the required qualifications, skills, expertise and experience.

- (ii) Further *discusses* the Immigration Control Act, 1993 (Act. No. 7 of 1993) in relation to the compliance by the employers and enforcement by the State machineries on the employment of foreign nationals in Namibia both in private and public sectors.

After debate, that this Motion be referred to the Parliamentary Standing Committee on Human Resources, Social and Community Development.
