The Council met pursuant to adjournment.

1.0 The Chairperson took the Chair.

2.0 The Chairperson recited the Prayer and Affirmation.

3.0 NOTICE OF MOTION(S)

3.1 Hon. Tobias moved a motion without notice: That leave of absence be granted by the August House in terms of Rule 36(4) of the National Council Standing Rules and Orders, to Hon. Ambrosius Kandjii for the period 25 April 2016 to 19 May 2016 due to illness/ill-health.

3.2 Hon. Tobias gave notice in terms of Rule 188(2) of the National Council Standing Rules and Orders: That on Tuesday, 17 May 2016, he shall move the Report of the Oshikoto Regional Council.

4.0 DEBATE ON COMMITTEE STAGE

4.1 FIRST ORDER READ
