The Council met pursuant to adjournment.

- 1.0 The Chairperson took the Chair.
- 2.0 The Chairperson recited the Prayer and Affirmation.
- 3.0 NOTICE OF MOTION(S)
 - 3.1 Honourable Ndjago gave notice: That on Wednesday, 03 August 2016, she shall move the consolidated Report of the Standing Committee on Urban and Rural Development on the Reports of the 14 Regional Councils.
 - 3.2 Honourable Sipapela moved in terms of Rule 51(1)(i) of the Standing Rules and Orders, a Notice without motion that this August House grant unanimous concurrence to the Select Committee on *Namibian Citizenship Amendment Bill* [B.11 of 2016] to table its report, on Wednesday, 03 August 2016.
